

MEMORANDUM OF UNDERSTANDING BETWEEN

SCHOOL OF HEALTH SCIENCES, SARI MULIA, BANJARMASIN, SOUTH KALIMANTAN, INDONESIA AND



FACULTY OF NURSING, KHON KAEN, THAILAND

School of Health Sciences SARI MULIA, a duly organized and recognized educational institution in Banjarmasin, South Kalimantan, Indonesia and KHON KAEN UNIVERSITY, a duly organized and recognized educational institution in Khon Kaen Thailand, wishing to establish mutually beneficial relations between them, hereby manifest:

NOW THEREFORE, the parties enter into this MEMORANDUM OF UNDERSTANDING, as follows:

- 1. In developing and pursuing mutually beneficial arrangements, the parties shall maintain transparency, mutual respect, and professionalism in dealing with each other.
- 2. The areas of cooperation and collaborative effort may include:
 - a. Benchmarking with the best practices and curriculum of KHON KAEN UNIVERSITY and enhancing the nursing program of STIKES SARI MULIA BANJARMASIN;
 - b. Conduct by KHON KAEN UNIVERSITY of post-graduate courses in nursing and other health sciences for Indonesians in collaboration with STIKES SARI MULIA BANJARMASIN;
 - c. Twinning programs in Nursing, Midwifery and other health sciences courses and exchange of students, interns, faculty, staff, academic materials, information;
 - d. Enhancement of English proficiency for STIKES SARI MULIA BANJARMASIN faculty and students;
 - e. Upgrading and development of STIKES SARI MULIA BANJARMASIN faculty and trainors in health sciences;
 - f. Collaborative research, publications, seminars, academic meetings and special short-term academic programs.
- The detailed terms of cooperation for each specific program or activity under this Memorandum of Understanding shall be discussed and agreed upon in writing by both parties prior to the initiation of that activity. Any such agreements entered

- into, as outlined above, will form appendixes to this Memorandum of Understanding.
- 4. Each institution shall designate a responsible person or officer to develop and coordinate the specific activities and programs to be agreed upon.
- 5. KHON KAEN UNIVERSITY and STIKES SARI MULIA BANJARMASIN shall endeavor to develop an inter-faith and multi-cultural programs and mechanisms to foster peaceful and mutually beneficial collaboration between the two institutions and among Thai and Indonesian students in an environment of peace and brotherhood.
- 6. This Memorandum of Understanding shall remain in force unless terminated by a party by giving six months prior written notice to the other party. This Memorandum of Understanding may be amended or extended between two parties by mutual consent and in writing.
