



MEMORANDUM OF AGREEMENT
BETWEEN

(STIKES Muhammadiyah Gombong) Indonesia

Muhammadiyah Gombong Institute of Health Science (STIKES Muhammadiyah Gombong), Indonesia, and Faculty of Public Health Khon Kaen University, are willing to strengthen their academic and scholarly link and collaboration between school and students of both universities as follows :

PUSPOSE OF AGREEMENT

The purpose of this agreement is to facilitates the parties with a goal of establishing cooperative academic relationships between the two universities in areas discussed below.

SCOPE THE AGREEMENT

The parties agree to work together towards a mutual goal of academic and scholarly cooperative projects for mutual interest to colleges, departments, and students of each university.

GENERAL AREA OF COOPERATION

Subject to the availability of funds and the approval of the interested parties of both institutions, the university shall to endeavor to develop this following areas of cooperation:

- a. Student exchange for mutual benefit of both institutions

- b. Research collaboration and research training in areas of shared research expertise and interest;
- c. Staff exchange to mutual benefit of developing teaching programs
- d. Scholarship providence for international students
- e. Any other area of cooperation to be mutually agreed upon by the parties

The parties agree that as an essential proposition to any cooperative endeavor, all participant of programs created to pursuant to this agreement will be selected with full respect for equal opportunity for all persons in accordance with the policies of each party and without regard to the race, sex, age, national origin or religious affiliation of participants or candidates for participation.

FINANCIAL ARRANGEMENTS

Both parties agree that all specific financial arrangements are to be negotiated separately for each component and are dependent on mutual interest and on the availability of funds.

ADMINISTRATION

The terms and necessary budget for each program and activity that is implemented under of term of this general agreement shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of the particular program or activity. Such work protocols shall be negotiated every three years.

Each parties will designate a contact person to develop and coordinate specific activities or programs.

DURATION OF AGREEMENT

This agreement will be effective from the date of signature for an initial period of four years. Thereafter it may be renewed for additional one-year periods, subject to revision or modification by mutual written agreement. Either party, by written notice to the other party no less than three months prior to the end of any such year period, may terminate this agreement at the end of the current year period.
