

This Agreement shall become effective when the representatives of the two Universities place their signatures below.


The text of this Agreement is established in English, and each university shall keep one copy.

**AGREEMENT OF ACADEMIC AND EDUCATIONAL COLLABORATION  
BETWEEN  
KHON KAEN UNIVERSITY  
AND  
NAGAOKA UNIVERSITY OF TECHNOLOGY**

Khon Kaen University and Nagaoka University of Technology hereby agree to promote academic and educational collaboration and exchange between the two universities, with the joint purposes of improving mutual understanding between the two universities and contributing to the advancement of activities in areas of mutual academic and educational interest.

**Contents of the Collaboration Program**

1. The two universities agree specifically to promote:

- (1) exchange of students;
- (2) exchange of visiting professors and research staff;
- (3) joint research on scientific and technological subjects;
- (4) joint scientific and technological meetings, symposia and lectures;
- (5) exchange of academic findings, publications, and other academic and educational information; and
- (6) other academic and educational collaboration and exchange approved as suitable by the two universities.

**Implementation of the Collaboration Program**

2. The activities listed above are to be carried out after mutual consultation between the two universities and each of the divisions concerned.

**Terms of the Agreement**

3. This agreement shall become effective when appropriate representatives of the two universities affix their signatures below, and shall remain effective for three years. At that time, should renewal of the agreement be desired by either university, the matter shall be decided after consultation between the two universities.

**Revision of the Agreement**


4. Should revision or termination of the agreement before the end of the effective term be desired by either university, the matter shall be decided after consultation between the two universities.

**Language Used**


5. The text of this agreement is established in English, and if any question regarding any part of the agreement arises, the two universities must find a solution in consultation with each other.
