

**MEMORANDUM OF UNDERSTANDING
BETWEEN
TOKYO MEDICAL AND DENTAL UNIVERSITY, TOKYO, JAPAN
AND
KHON KAEN UNIVERSITY, KHON KAEN, THAILAND**

1. Parties

The parties to this Agreement are

- Tokyo Medical and Dental University, Tokyo, Japan, hereafter referred to as “TMDU”
- Faculty of Dentistry, Khon Kaen University, Khon Kaen, Thailand, hereafter referred to as “KKU-Faculty of Dentistry”

The two institutions wish to expand co-operation in disciplines relating to Dental Health Sciences and others area of mutual interests and to promote closer academic collaboration and thereafter agree as follows.

2. Upon the mutual consent of the parties, including the relevant academic management units within the universities, and subject to the availability of funds, collaboration may be carried out in, but not necessarily limited to, any of the following activities:

- Exchange of students, academic and administrative faculty members, visiting scholars and others staff mutually agreed upon at the two institutes.
- Visits between universities by academic staff (faculty)
- Collaborative research and publication
- Sharing of scientific materials, publications and information
- Joint organizations of conferences, seminars or other academic meetings.
- Joint organizations of special technical or administrative programs.
- Joint production and delivery courses and programs

3. Addenda to this document identify specific projects, which will be undertaken within this overall Agreement, and the details of their management. Further addenda may be developed at any time, but require the signatures of both Deans in order to be implemented as part of this Agreement.

4. The financial arrangements involved in the implementation of this agreement shall be settled through consultation between the two institutions in respect of each program of co-operation.

5. Each institution will take action to make the substance of this Memorandum of Understanding known to its appropriate personnel, and will provide normal and reasonable assistance to such personnel in regard to the administrative details of exchanges and work agreements.

6. Any modifications to the present Agreement shall be undertaken by mutual decision in writing at any time and any new changes will start on a date agreed by both Universities.

7. The parties agree that each may publish or advertise the existence and nature of activity under this Agreement, provided that the partner does not indicate in writing that a specific matter should remain confidential.

8. The assignment of this Agreement to any other party or parties is expressly prohibited except with the written concurrence by the appropriate authorities of both TMDU and KKU-Faculty of Dentistry.

9. This Agreement will be effective upon signature by the Chief Executive Officers or their delegates for a period of five years, at which time it will be reviewed for the possible of renewal for further five-year periods.


10. Either party may, on six months notice in writing, terminate the Agreement in advance of its normal expiration or request the renegotiation of its conditions. Under such circumstances, staff or students who have commenced an activity under the Agreement should be allowed to complete the activity, under the conditions applying when notice was given.

Fully accepting the articles stated above, the parties hereby sign this Agreement in two (2) equally dated copies, in English language, with a copy to each part.


