



**MEMORANDUM OF UNDERSTANDING**  
**between**  
**UNIVERSITY OF PUTHISAстра, CAMBODIA**  
**and**  
**KHON KAEN UNIVERSITY, THAILAND**



University of Puthisastra (UP), Cambodia and Khon Kaen University (KKU), Thailand agree to enter into this Memorandum of Understanding (MOU) based on a foundation of trust for the mutual benefit and development of the two institutions and the promotion of international understanding and goodwill.

1. UP and KKU will jointly develop some or all of the following activities based on their respective academic and educational needs:
  - a. exchange of academic staff and researchers;
  - b. exchange of undergraduate and graduate students;
  - c. exchange of administrative and other non-academic staff;
  - d. joint development of research projects;
  - e. exchange of research outcomes, academic publications, and other academic information such as courses and subjects;
  - f. joint organization of scientific and cultural events;
  - g. other academic and educational exchange programs approved as suitable by both institutions.
2. The implementation of exchange programs under this MOU shall be separately negotiated and determined by both universities.
3. Nothing shall diminish the full autonomy of either institution, nor will any constraints or financial obligations be imposed by either upon the other in carrying out the agreement.
4. All promotional material used by either institution relating to this MOU must be submitted to the authorized legal representative of the other institution for approval in writing prior to publication.
5. Neither institution shall disclose to any person any confidential information relating to the business, clients, financial information, employee information or technology of the other institution which they may receive in the course of the MOU without the other party's prior consent. Either institution shall treat all confidential information as confidential and shall not disclose or make use of such information except in relation to the performance of their obligations in terms of this MOU.

6. The MOU is subject to revision or renewal by mutual agreement. Either institution may terminate the agreement by providing not less than 6 months' notice of termination to the other institution in order to avoid any possible inconvenience to all parties.
7. The MOU will be valid for five years and become effective when the representatives of both institutions have signed and dated the document.
8. The MOU shall be established in English. Should any questions on any part of this agreement arise, both institutions must consult with one another to find a solution in good faith.
