



**MEMORANDUM OF UNDERSTANDING
BETWEEN
DEMONSTRATION SCHOOL OF KHON KAEN UNIVERSITY, KHON KAEN, THAILAND
AND
SMA 17 AGUSTUS 1945 SURABAYA, INDONESIA
YAYASAN PERGURUAN 17 AGUSTUS 1945 SURABAYA, INDONESIA**

In the spirit of academic and friendly relations between our two educational institutions, this Memorandum of Understanding is made between Demonstration School of Khon Kaen University under the Faculty of Education, Khon Kaen University, Thailand and Sekolah Menengah Atas (SMA) 17 Agustus 1945 Surabaya under the Foundation of 17 Agustus 1945 Surabaya, Indonesia in order to promote mutual understanding between Indonesia and Thailand and foster international cooperation in education and cultural exchange.

Demonstration School of Khon Kaen University and SMA 17 Agustus 1945 Surabaya (herein referred to as "the parties"), recognizing the importance of education and training in national development,

HAVE REACHED THE FOLLOWING UNDERSTANDING

- This Memorandum of Understanding (hereinafter referred to as the "MoU") shall provide the framework within which detailed proposals for programs of education and training shall be jointly considered by the parties on the basis of respectful reciprocity and mutual benefit.
- Cooperation activities under this MoU shall be subject to the laws and regulations of each country.

GENERAL AREAS OF CORPORATION

1. Both parties agree to encourage the following activities in particular to promote international academic cooperation:
 - (1) Exchange of materials in education and culture;
 - (2) Exchange of students;Before these activities can be implemented, both parties shall discuss to obtain the satisfaction of each party and may enter into specific Activity Agreement based on the forms of implementation mutually agreed upon. The exchange should be on a mutual and reciprocal basis between the two parties.
2. This Memorandum of Understanding shall be applicable to the educational and culture attached to each party.
3. Both parties will try their best to accommodate the basic rights of their students.
4. Each party shall designate a liaison office for this general Agreement.

DURATION OF THE MEMORANDUM


1. This MoU shall become effective as of the date of signature by representatives of both parties and shall remain in force for an initial period of five years. Both parties agree that this MoU should be reviewed approximately every five years in order to evaluate progress and improve the quality of the cooperation and exchange.
2. Each party may terminate this agreement or request re – negotiation of its conditions at anytime by written notification 6 months prior to the termination. However, such action will only be taken after mutual consultation in order to avoid any possible inconvenience to all parties. Should a party terminate its involvement, currently participating students and faculty members will be permitted to complete the period of their exchange.
