

MEMORANDUM OF UNDERSTANDING

between

Khon Kaen University, Thailand



and

Universitas Muhammadiyah Yogyakarta, Indonesia

THIS MEMORANDUM OF UNDERSTANDING is made on September ___, 2017 between

KHON KAEN UNIVERSITY (hereinafter referred to as "KKU"), an institution of higher learning established as a university in 1964 and having its address at 123 Moo 16, Mittrapap Road, Naimuang, Muang District, Khon Kaen 40002, Thailand, of the one part; and

UNIVERSITAS MUHAMMADIYAH YOGYAKARTA (hereinafter referred to as "UMY"), a private institution of higher education learning established in March 1981 as part of Muhammadiyah social organization and having its address at Jl. Lingkar Selatan, Tamatirto, Kasihan, Special Region of Yogyakarta, INDONESIA; of the second part.

KKU and UMY shall hereinafter referred to singularly as "the Party" and jointly as "the Parties".

Both parties recognize the benefit of strong international links. To achieve this aim we propose the following agreement:

- 1. The purposes of this agreement are to develop academic and education collaboration and to promote a joint relationship between the KKU and UMY.
- 2. Both institutions undertake to promote and develop cooperation in the following ways, on the basis of equality and reciprocity:
 - a. Exchange of teaching staff/lecturers
 - b. Exchange of researchers
 - c. Exchange of students
 - d. Exchange of academic information and publications
 - e. Conducting reciprocal lectures and seminars
 - f. Cooperating in research and the publication of its result

- g. Identifying other mutually agreed opportunities for collaboration
- 3. To implement these forms for cooperation, the representatives of our individual institute/faculty will be encouraged to consult with each other and to develop specific plans for collaboration in any or all of the ways outlined in agreement two above.
- 4. It is understood that the implementation of any of the types of the cooperation stated in agreement two above shall depend on our mutual availability of resources and financial support from our respective institutes/faculties.
- 5. This agreement will come into effect on the date when the representatives of both parties sign the agreement and will thereafter remain valid for a period of 5 (five) years. The agreement may be extended after mutual discussion with representatives of both parties. Such discussion needs to commence not later than six months before the termination of the agreement.
- 6. The agreement may be revised or modified during this period by mutual consent. Similarly, the agreement may be terminated within this period by either party provided that six months notice is given to the other.
- 7. The evaluation will be conducted by KKU and UMY after five years of implementation of this MoU.

IN WITNESS THEREOF, the parties hereby to execute this agreement.
