



The Agreement
Between
Faculty of Humanities and Social Sciences, Khon Kaen University
And
School of Foreign Language, Baise University (SFL-BSU)

In the interest of establishing a relationship of mutual benefit to both parties, School of Foreign Language, Baise University (SFL-BSU) and Faculty of Humanities and Social Sciences, Khon Kaen University (HUSO KKU) agree to develop a program for SFL-BSU Students to study at HUSO KKU for one academic year with the terms and conditions described as follows :



1. Beginning in 2015, HUSO KKU agrees to accept 35 SFL-BSU students to study at HUSO KKU for one academic year. Details of the program are as follows:
 - The program for SFL-BSU students will start in August and end at middle of the following year.
 - Course for SFL-BSU students will be mainly Thai Language courses aimed at raising the students' Thai proficiency level.
 - HUSO KKU will provide transcripts to both students and SFL-BSU after at the end of the second semesters.
 - At the end of the second semester, after completing all the requirements at HUSO KKU, SFL-BSU students will get a certificate from HUSO KKU.
2. Each year, before the end of May, SFL-BSU will provide HUSO KKU with the number of SFL-BSU students who would like to study at HUSO KKU ; HUSO KKU will send an original copy of acceptance letter to SFL-BSU accordingly.
3. Each SFL-BSU student at KKU is responsible for the following :
 - Housing
 - Meals
 - Books and Materials
 - Miscellaneous living expense and personal spending money
 - Health and accident insurance
 - Any Application Fees for Visa Extension /Reentry Permit / Residence Permit
 - Registration Fees

4. HUSO KKU will bear full responsibility of supervising SFL-BSU students while they are fully enrolled in courses at HUSO KKU. HUSO KKU is to assign a faculty member to handle the daily management of the program , whose responsibilities, among others, include :
 - Academic Affairs (including teaching observation and practice)
 - Logistics of the program
 - Assistance in applying for Visa Extension / Reentry Permit / Residence Permit;
 - Orientation and consultation
 - Safety of the students and safety education.
5. Both parties must designate a contact person whose responsibility is to coordinate and inform the other party of the progress of the program. If one party changes the contact person, they must inform the other party of the change in writing.
6. This agreement shall remain in force for a period of five (5) years. Either party may terminate this agreement by not less than six (6) months' prior written notice to the other party of its desire to terminate. This agreement may be extended by the mutual agreement of both parties in writing.
7. The termination of this agreement shall not affect the implementation of the projects or programmes established under it prior to such termination.

The foregoing agreement between SFL-BSU and HUSO KKU having been duly approved by both parties is hereby executed by the undersigned authorized representatives of each party, to be effective upon the date of signature
