



MEMORANDUM OF UNDERSTANDING

between

HANOI UNIVERSITY, VIETNAM

and

FACULTY OF HUMANITIES AND SOCIAL SCIENCES, KHON KAEN UNIVERSITY, THAILAND

Hanoi University (HANU), Vietnam and Faculty of Humanities and Social Sciences, Khon Kaen University (HUSO - KKU), Thailand (hereinafter referred to as "the Parties"), in accordance with the mutual desire to promote co-operation between the two Universities, have reached the following understandings:

General Adjectives

- This Memorandum of Understanding provides the framework within which detailed proposals for programs of education co-operation in respect of the common activities are to be jointly considered between the two Parties. This Memorandum will have from time to time annexure attached to it with regard to these specific programs, in the areas of Foreign Languages and other.
- 2. The Parties undertake to encourage:
 - a. Co-operation in education and training, including curriculum development, specialized training courses, staff development and the promotion of staff and student exchanges
 - b. The exchange of information on education and training systems
 - c. Joint research activity in fields of mutual interest
 - d. Cultural Exchange Programs

Funding

As a general principle, the costs of co-operative activities undertaken pursuant to this
Memorandum of Understanding will be funded on a mutually agreeable basis.

Consultation

 Representatives of the Parties will convene by mutual agreement to review the operation of this Memorandum of Understanding.

Settlement of Disputes

Any disputes arising from interpretation of implementation of this Memorandum of Understanding will be resolved by consultation between the Parties.

Implementation

- Each Party will facilitate the arrangement of other activities in its territory not specifically mentioned in this Memorandum which are in accordance with the spirits of this Memorandum.
- 7. Either Party may terminate this Memorandum of Understanding on giving not less than six months' prior written notice to the other Party.
- 8. This Memorandum will remain in effect for a period of five years, and can be renewed upon the agreement of both Parties.
