## **B. Articles**

Both parties agree to the articles below:

UL HU and KKU will jointly develop some or all of the following activities based on their respective academic and educational needs:

#### **B-1 Exchanging of lecturers and students:**

Exchange of students, staff and non-academic staff on a yearly basis; (e.g. cooperating in providing accommodation support for visiting staff; facilitating the reception of each other's lecturers and students)

#### **B-2 Exchanging of scientific research**

Exchange of research materials, publications and information; (both universities exchange the electronic research materials/documents for each other)

Organization of joint research programs; (e.g. both universities collaborate to do research which is two sides' interests)

Other activities agreed by two institutions such as

agree to hold a scientific workshop every two years (in Vietnam and in Thailand). The topic is chosen by both; arranging for lecturers to teach the law profession (in English) to support the training programs etc.

**B-3 Support for distance learning courses,**  
Support for distance learning courses with mutual written consent before expenses are incurred.

### **C. Indemnity**

C-1 The implementation of exchange programs under this agreement shall be separately negotiated and determined by both universities.

C-2 This agreement is not legally binding. Nothing shall diminish the full autonomy of either institution, nor will any constraints or financial obligations be imposed by either upon the other in carrying out the agreement.

C-3 This Memorandum is subject to revision or renewal by mutual agreement. It is also understood that either institution may terminate the agreement at any time, although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to all parties.

### **D. Term**

D-1 This agreement is not legally binding.

D-2 This agreement is considered as an honourable agreement and will commence upon the execution of this agreement by the last of the parties to execute it.



D-3 The Memorandum will be valid for five years and become effective when the representatives of both institutions have signed and dated the document.

D-4 The effective period is 05 years and it will be extended so long as neither party expresses a desire to terminate or modify this MOU.
