

## MEMORANDUM OF UNDERSTANDING



Between

**Macquarie Education Group Australia (MEGA)**

**Khon Kaen University (KKU)**

And

**AIEC Student Service ("AIEC")**

(individually referred to as "party", and collectively referred to as "parties")

Macquarie Education Group Australia ("MEGA") having its principal office at Level 9, 225 Clarence Street, Sydney, New South Wales, Australia, Khon Kaen University ("KKU") having its principal office 123 Mittraphap Road, Muang District, Khon Kaen 40002, Thailand, and AIEC Student Service ("AIEC"), 18/26 Busaco Road, Marsfield, New South Wales, Australia (ABN 43 706 466 952) considering their common interest in promoting the mutual collaboration in the area of education and research, have set forth the following Memorandum of Understanding ("MOU").

### 1. Purpose

The purpose of this MOU is to develop academic and educational collaborations on the basis of equality and reciprocity and to promote relations and mutual understanding between MEGA, KKU and AIEC.

MEGA is an Australian Registered Training Organisation with its courses recognised by many top 2% world ranked Australian universities.

### 2. Scope of Cooperation

Both parties undertake to promote and develop academic collaborations which include but are not limited to the following:

- Collaboration in branding and marketing
- Joint participation in internationally projects
- Joint academic activities for students and staff at parties' campuses
- Promoting MEGA & KKU Courses for students and staffs



- Promoting MEGA's Smarter Pathways, giving direct access for KKU's students to top Australian universities
- Delivering MEGA's courses (or part of MEGA's courses) at KKU's campus in Thailand
- MEGA scholarship offers for KKU's staff and students

### 3. Arrangements of Implementation

- 3.1 A detailed written description of the collaboration, including financial arrangements, will be developed mutually for each specific case and will be subject to the review and approval processes of both parties.
- 3.2 The parties will ensure that all public statements including statements to the media or articles relating to the collaboration are cleared and consented by both prior to release or publication.
- 3.3 Neither party shall use the name or logo of the other party for any purpose whether in relation to any advertisement or other form of publicity without obtaining the prior written consent of the other party.
- 3.4 The parties will evaluate the collaboration on a yearly basis.
- 3.5 The parties agree to designate the following persons as the local representatives for the coordination of the collaboration:
  - a. For MEGA: Dr. Sutida (Sangkamane) Jackmetha
  - b. For KKU: Assoc. Prof. Dr. Pensri Jaroenwanit
  - c. For AIEC: Mr. Montien Chaisuwankeeree

### 4. Duration of MOU

This MOU will be effective upon signatures by both parties. It will be in force for five years and may be revised and/or renewed upon mutual written consent. Either party may terminate this MOU by giving a six-month prior written notice to the other party. Such termination shall not affect the validity and continuity of any incompletely discharged obligation agreed upon by the two parties before termination.

### 5. AIEC Student Service (ABN 43 706 466 952)

AIEC will provide the following services to KKU students;

- Student accommodation services - homestay inspection and homestay placement
- Transportation arrangement (airport pick up & opal cards for bus, train and ferry)
- Banking (opening bank accounts)
- VISA preparation and submission
- Emergency contact (24/7)
- Pre and post departure orientation
- Student Tax File Number (TFN) application
- Internship workshops
