



# MEMORANDUM OF AGREEMENT

between

# FACULTY OF NURSING, MUHAMMADIYAH UNIVERSITY OF JAKARTA, INDONESIA and FACULTY OF NURSING, KHON KAEN UNIVERSITY, THAILAND

Faculty of Nursing Muhammadiyah University of Jakarta, Indonesia and Faculty of Nursing Khon Kaen University, Thailand wish to strengthen their academic and scholar links and collaborations between school and students of both universities agreement as follows:

#### PURPOSE OF AGREEMENT

The purpose of this agreement is to facilitate the parties with a goal of establishing cooperatively academic relationships between the two universities in the areas discussed below.

#### SCOPE OF AGREEMENT

The parties agree to work together toward a mutual goal of academic and scholarly coopertative projects that are of mutual interest to colleges, departments, and students of each university

#### GENERAL AREA OF COOPERATION

Subject to the availability of funds and the approval of the interested parties of both institutions, the university shall endeavor to develop these following areas of cooperation.

- a. Student exchange for mutual benefit of developing study
- b. Research collaboration and research training in the areas of sharing research expertise and interest
- c. Staff exchange for mutual benefit of development teaching
- d. Any other areas of cooperation to be mutually agreed upon by both parties

The parties agree that as an essential proposition to any cooperative endeavor, all participants of programs created to pursue this agreement will be selected with full respect for equal opportunity for all people in accordance with the policies of each party and without regard to the race, sex, age, national origin or religious affiliation of participants or candidates for participation.

## FINANCIAL ARRANGEMENT

Both parties agree that all specific financial arrangement are to be negotiated separately for each component and are dependent on mutual interest and on the availability of funds.

### **ADMINISTRATION**

The terms and necessary budget for each program and activity that is implemented under term of this general agreement shall be mutually discussed and agreed upon in writting by both parties prior to the initiation of the particular program or activity. Such work protocols shall be negotiated every three years.

Each parties will designate a contact person to develop and coordinate specific activities or programs

# **DURATION OF AGREEMENT**

This agreement will be effective for 5 years from the date of signature between both parties. Thereafter it may be renewed for additional period, subject to revision or modification by mutual written agreement. Each party, by written notice to the other party no less than three months prior to the end of any such year period, may terminate this agreement at the end of the current year period.
