



Memorandum of Agreement

on

the International Dual Degree Program

between

Khon Kaen University

and

Chia Nan University of Pharmacy and Science

Under the terms of "Memorandum of Agreement (MoA)" between Khon Kaen University (KKU) and Chia Nan University of Pharmacy and Science (CNU) ratified and effective on the day of signature, the Parties hereby agree the following terms for the implementation of an International Dual Degree program:

Both CNU and KKU (Both Universities) agree to implement the International Dual Degree Program as stipulated in the terms below:

- 1. The program is to be brought into effect by the Department of Environmental Engineering and Science, CNU, and the Department of Environmental Science, KKU.
- 2. The program's purpose is to help students of both universities to study for a dual degree of MS/ME, which will be jointly conferred upon the student by the two universities after he/she has fulfilled all the requirements as stated below:
 - a. The student must study at CNU for at least 2 semesters and at KKU for at least 2 semesters.
 - b. The student pays all required tuitions and fees at his/her home university.
 - c. The student must complete the Degree requirements of both universities.
 - d. The KKU students must take at least 10 more credits at CNU (including 6 credits for thesis and 4 credits for other related environmental engineering courses) and the CNU students take at least 15 credits (12 credits for thesis and 3 credits for core courses) at KKU.
 - e. The student finishes the thesis within the stipulated time period and passes all required examinations at Both Universities.
- 3. To enter the program, the student must be a registered full-time student at his/her home university. In addition, the student must provide proof of adequate financial resources (accommodation, living expenses and transportation) to study in his/her host university.
- 4. To apply for admission to the program, the student must complete an application form, including all necessary information, and send it first to his/her home university, and then to the host university for final approval.
- 5. All students admitted to the program must arrive at the host university before a set

deadline and follow all school regulations. Any student who wishes to extend his/her study, for any reason, must acquire the approval of Both Universities beforehand. In the case of termination of the program, the student can obtain degree from whichever university he/she has fulfilled all its requirements.

- 6. All Intellectual Property generated in this program and/or activities covered by this MoA are deemed to be joint property of Both Universities.
- 7. Eligible faculty members of Both Universities can act as co-advisors of students in this program.
- 8. This agreement may be revised, but only with the consent of both universities. Any proposals for alteration of this agreement must be submitted to the concerned parties in such a manner as to allow sufficient time for consideration and for mutual understanding to be reached.
